4	WHEREAS pursuant to Article 3, Section 3.1 of its charter the University Assembly (the
5	Assembly) may propose changes to the Campus Code of Conduct (the Code) subject to the
6	University President's approval;

5	policy until such time as the Campus Code of Conduct is amended to fulfill the requirements of Title IX; and

22 23 24	The Appendix found on page 42 of the Code will be changed as follows:

25	Article I. 17 May 2011 Motion Regarding Procedures for Violations Involving Sexual
25 26	Violence and Sexual Assault
27	The following motion was approved on 17 May 2011:
28	"Be it resolved that, in cases of sexual violence and sexual harassment (as identified in
29	Sections 1(A) and 1(C)) arising under the Campus Code of Conduct, the standard of
80	proof will be preponderance of evidence and all rights of appeal afforded to the accused
31	will also be afforded to the complainant."

33	Offenses involving sexual violence and sexual harassment, while still violations of the
34	Campus Code of Conduct, will be investigated and adjudicated under Cornell University
35	Policy 6.4 until such time as the Code is amended to fulfill requirements of Title IX.
