- a. Gina Giambattista, Office of the Assemblies
  - i. G. Giambattista: Thank you all for your participation in the shared governance of Cornell. Shared governance allows students, faculty, and staff to be a part of the decision-making process for Cornell. The representatives are elected, and these representatives are able to make and recommend policy decisions the highest ranks of the university. Every member of the Cornell community is represented through shared governance. Whether not members of the community actively participate,

they should be aware that they are being represented and that their voices can be heard. The authority of the assemblies comes from the university trustees. Our job in the office of assembly is provide support to all of the committees, assemblies, and elections, as well as update and publish the public records. We are also here to encourage participation from the Cornell community. We commonly work with data, HR, and work closely with the university registrar. What we can we do for you? We support the assembly, maintain the website with tools for members, and are here to be a resource for all matters GPSA. Our office is Day Hall 109 and are doors is usually open, feel free to stop by with any questions! All the assemblies have a mandate to represent constituent issues and bring it to the attention of the university. The assemblies charter serves as a constitution, and there are ways to amend the constitution, but they must be approved by the president of the university. The procedures during the assembly follow Robert's Rules of Order. We encourage members of the assembly to engage with stakeholders and use our resources.

  - i. A. Cohn: The GPCI is a strategic plan made by the GPSA used to address non-academic graduate student life. It is rewritten every five years to address new issues. It was originally created in 2008 to provide a vision for Cornell on how to serve the graduate student community.
