



## Resolution 61: Calling for the Termination of Cornell University's Partnership with the Technion – Israel Institute of Technology While Preserving Cornell Tech

**Abstract:** This resolution calls on Cornell University to terminate its institutional partnership with the Technion – Israel Institute of Technology while maintaining Cornell Tech as an independent Cornell campus. It cites ethical and legal concerns regarding the Technion's involvement in military research and technologies linked to human rights violations, arguing that continued collaboration conflicts with Cornell's values and mission. The resolution further urges divestment from joint programs and the implementation of transparent ethical review processes for international partnerships.

**Whereas,** Cornell University operates the Cornell Tech campus in New York City through an institutional partnership with the Technion – Israel Institute of Technology,

**Whereas,** members of the Cornell community have raised serious ethical concerns regarding the Technion's documented role as a major research and development institution for the Israeli military,

**Whereas,** the Technion institute has been implicated in the design and development of technologies used in separation walls and surveillance infrastructure that violate international law, including rulings by the International Court of Justice, which prohibit states and institutions from rendering aid or assistance in maintaining such structures,

**Whereas,** Cornell University funds joint military and defense-related research through the Jacobs–Technion Institute, raising concerns about Cornell's material involvement in military applications,

29 **Whereas**, Israeli companies have publicly acknowledged testing weapons and military  
30 technologies—developed in part through Technion research—on captive Palestinian populations,  
31 explicitly marketing such technologies as “field-tested”,

32 **Whereas**, complicity in genocide, apartheid, or grave human rights violations by non-state  
33 actors, including universities, is increasingly recognized as a violation of international law and  
34 ethical responsibility,

35 **Whereas**, partnerships with institutions that contribute to the production of weapons, military  
36 technologies, or infrastructure of apartheid are inconsistent with Cornell University’s stated  
37 educational mission, ethical commitments, and core values,

38 **Whereas**, the continued operation of Cornell Tech as a Cornell University campus does not  
39 require an ongoing partnership with the Technion – Israel Institute of Technology,

40 **Be it therefore resolved**, that the Student Assembly calls on Cornell University to immediately  
41 terminate its institutional partnership with the Technion – Israel Institute of Technology,

42 **Be it further resolved**, that the Student Assembly affirms its support for the continued operation  
43 of Cornell Tech as a Cornell University campus, independent of the Technion partnership,

44 **Be it further resolved**, that the Student Assembly calls on Cornell University to implement  
45 transparent ethical review processes for all international partnerships, particularly those  
46 involving military, surveillance, or dual-use technologies,

47 **Be it finally resolved**, that the Student Assembly urges Cornell University to ensure that its  
48 institutional relationships align with international law, human rights principles, and the  
49 university’s educational mission.
