- 4 regarding the future of Anabel's Grocery, ensuring its continued operation and role in addressing
- 5 food insecurity at Cornell University.

- Whereas, food insecurity is a pressing issue at Cornell University, affecting students' ability to
- focus on their academics and overall well-being.
- Whereas, to combat this issue on campus, the 2014-2015 Student Assembly passed <u>Resolution</u>
- 15 <u>65: Developing and Funding a Student-Run Grocery Store</u>, which led to the creation of Anabel's
- 16 Grocery using money from the Student Assembly's Students Helping Students Grant.
- Whereas, Anabel's Grocery is a student-run nonprofit grocery store that provides fresh,
- nutritious, and affordable food to Cornell students, while also offering educational programming
- 19 and community engagement opportunities.
- Whereas, the recent severance of the Student and Campus Life Department's affiliation with the
- 21 Center for Transformative Action (CTA) and related redirection of annual endowment income
- 22 previously allocated to CTA has placed Anabel's Grocery in financial jeopardy, as CTA has
- 23 historically provided essential administrative, financial, and legal support for the store.
- Whereas, Anabel's Grocery requires new financial support, including funding for a part-time
- 25 store manager, faculty support for the related course, maintenance of operations, and the subsidy
- 26 fund for affordable food access.
- Whereas, the Student Assembly has a responsibility to ensure that critical student services
- 28 remain accessible, especially those that promote food security, student well-being, and
- 29 community engagement.
