31	Be it finally resolved, §7, the Voting Section, of Appendix A of the Student Assembly Charter be

34	Section 7: Voting
35	Proxy votes shall not be permitted for decisions of the Student Assembly regarding the SAF
36	during the SAF allocation process. The Student Assembly must approve the appropriations
37	committee decisions by a majority of the voting membership of the Student Assembly
38	members present at the meeting and can overturn an appropriations committee decision by a
39	two-thirds (2/3) vote of Student Assembly members present at the meeting. If the Student
40	Assembly overturns a decision of the appropriations committee, the Student Assembly must
41	decide Activity Fee funding for that organization by a majority of the Student Assembly
42	members present at the meeting. After all appropriations committee decisions have been

43		approved or overturned, the Student Assembly must approve the SAF by a majority of the
44		voting membership of the Student Assembly.
