I. Call to Order -12:15

II. Call for Late Additions to the Agenda

T. Grove added the Student Assembly Resolution, Ban the Box, to New Business.

III. Approval of Minutes

There was a minutes from March 16th were approved by a unanimous vote.

IV. Business of the Day

- Gary Cremeens- Update from TCAT
- G. Cremeens from Cornell Transportation Services introduced himself and stated that TCAT might be making summer service changes.
- Meetings to inform the public of these potential summer service changes will take place Thursday April 7th from 5:30 p.m to 7:30 p.m in Weill Hall Room 226 and on Friday April 8th from 11a.m to 1p.m in Maplewood Apartments Community Center.
- O. G. Giambattista asked if the changes have already been made and G. Cremeens replied that TCAT is looking to make a cut in the services during the summer but the changes have not been made yet.
- o A. Kohut asked if the changes are only for the summer.
- o G. Cremeens said they are just looking at summer cuts and they are also pushing for recruitment.
- o M. de Roos asked about TCAT's Citizen Advisory Board and G. Cremeens said there is a low representation from the Cornell community but those that are representing the board are compromised of the people who take the bus.

Resolution Ban the Box

- o G. Lovely explained the Ban the Box Resolution was created in order for Cornell University to remove the conviction question from its job application.
- o M. de Roos asked if currently the question is asked to employees.
- o G. Lovely said there is currently no box in the application process but applicants are asked to have an employment background check.
- o B. Kepner asked if Cornell has the box.

- o G. Lovely said Cornell's New York City Campus does not but Cornell does.
- o A. Kohut asked if a background check is necessary.
- o G. Lovely said employer could ask for background check but it is not required.
- o G. Lovely said exceptions to this rule can be made for temporary positions.
- o J. Kruser wondered if no background check is required then the current box policy must not be doing anything.
- o T. Grove said there is a new recruitment system for hiring. On April 18th they will start using workday.
- o G. Lovely reported that Alan Mittman said he not able to currently look into this.
- o G. Lovely said he needs strong support from the community.
- L. Majani said people seem in agreement with the idea but it would be beneficial if they
 communicate with those that are resistant toward the Resolution therefore they can come
 to an agreement.
- o B. Kepner said this is currently a Student Assembly Resolution and they need to change the heading to Employment Assembly.
- o The Resolution will be presented in the next Employee Assembly meeting.
