VIII. Presentations

- a. Mary G. Opperman, Vice President and Chief Human Resource Manager and Dr. Vijay Pendakur, Dean of Students, Core Values Statement
- b. M. Opperman: Core values do not change, and involve how we interact with each other. They guide all aspects of life personal and work, and need no external justification. They are not business strategies. University Texas at Austin, Southwest Airlines, Starbucks are all examples. Our next steps are to have a discussion with all assemblies, create draft, draft on website for campus and community consent.
- c. Dr. V Pendakur: Opens the discussion to the assembly to hear proposed core value statements, with M. Opperman taking notes. Audio cuts in and out
 - i. A. Loiben: to me any person, any study I think of equal opportunity and that anyone who wants to be here is able to come and study
 - ii. A. Barrientos-Gomez: Is there a currently system of feedback currently.
 - iii. M. Opperman: The university does not currently have a core value statements.
 - iv. J. Bogdanowicz: In our breakout group we talked about the idea of cultivating a whole person
 - v. A Representative: Is Cornell specifically looking for something?
 - vi. M. Opperman: This came as a recommendation from the presidential task force, and they core values will be used for guiding decisions and actions. They have many uses.
 - vii. Dr. V Pendakur: From other institutions they are usually multiple statements
 - viii. Nate: Our status as a land grant institution fill in some values for us such as ROTC
 - ix. Dr. V Pendakur: Our land grant status is framed more of a legal status than as a value.
