

## GPSA Resolution 8: Cornell Investment and Divestment Strategies for a Sustainable Future

- 1 WHEREAS there is overwhelming evidence that the use of fossil fuels is disrupting the Earth's
- 2 climate system and acidifying its oceans, and that such disruptions will create significant
- 3 challenges for Cornell University, the state of New York, the United States, and all countries for
- 4 the next millennium; and
- 5 WHEREAS Cornell has committed to becoming carbon neutral by 2050 and has made
- 6 significant progress in achieving this goal; and
- 7 WHEREAS many other colleges and universities have also committed to achieving this goal,
- 8 with some having established an even more ambitious goal of eliminating fossil fuel use of 2025;9 and,
- WHEREAS reducing the use of fossil fuels will reduce the value of investments in companiesholding large fossil fuel reserves; and
- WHEREAS Cornell is a leading research and public education institution with significant impact
  within New York, the United States, and the world; and
- 14 WHEREAS the Cornell Student Assembly and Faculty Senate have passed by overwhelming

15 majorities resolutions calling upon the University to adjust it investment practices to draw further

- 16 attention to the detrimental effects of fossil fuel use; therefore be it
- 17 RESOLVED that Cornell graduate and professional students, responsible university offices and
- 18 officials should seek a more aggressive reduction in the use of fossil fuels that will achieve
- 19 carbon neutrality by 2035; and,
- RESOLVED that Cornell investments in companies producing such fuels be reduced consistent
  with Cornell's progress toward carbon neutrality so as to achieve full divestment by 2035; and,
- RESOLVED that this should be done by a schedule that prioritizes divestment from those companies holding the largest fossil fuel reserves; and,
- 24 RESOLVED that the President of Cornell will submit an annual report to the Student Assembly,
- 25 Graduate and Professional Student Assembly, and the Faculty Senate describing the progress that
- 26 the University has made in becoming carbon neutral and divesting from companies holding the
- 27 largest fossil fuel reserves; and,
- 28 RESOLVED that this Resolution be sent to David Skorton, President of Cornell; Robert
- 29 Harrison, Chair of the Board of Trustees; Kent Hubbell, Dean of Students; Susan H. Murphy,
- 30 Vice-President for Student and Academic Services; Kent Fuchs, Provost; Barbara Knuth, Vice
- 31 Provost and Dean of the Graduate School
