Good evening,

My name is Steve Tarcn and I am reaching out tonight to make the Office of Assemblies aware of early campaigning from one of the current candidates for the graduate & professional student trustee position, Jeff Pea. Jeff has both a [campaign website](#) and a [campaign Instagram account](#) (that already has followers), and he has already reached out to various student leaders inquiring about their positions in organizations and what they are interested in. The reason I am bringing this up is because I know campaigning does not officially start until tomorrow, Friday, October 16, 2020 and candidates were told to “refrain from any of the following campaign activities, including: (a) disseminating printed or **electronic campaign materials**; (b) advertising candidacy by chalk, poster, **social media, electronic**, or other means; and/or (c) making speeches or statements about their candidacy to any press, **student organizations**, employee organizations, campus organizations, university departments, or class.

To sustain my claims, I am including pictures of Jeff’s Instagram page, campaign website, and an email he sent to a student leader. (The person who sent me a screenshot of Jeff’s email asked me to not disclose their personal information.) Overall, I find Jeff’s attempt to early campaign extremely inappropriate considering the magnitude of this position. These actions reek of privilege and completely disregard the rules set in place.



improving investment & accessibility for student well-being

Wellbeing is impacted by every aspect of life and students, both undergraduate and graduate, feel that much of their current lifestyle at Cornell limit their overall wellbeing. This remains a major community concern that I believe requires a holistic approach to help create a campus space that students can thrive in. If elected, I would advocate for the following:

1. **Improved coverage & accessibility of mental health services**
2. **Better facilities and affordable programs for fitness centers**
3. **More personalized, standardized academic advising across all colleges and a centralized career services center for all students**
4. **Policies for a more affordable campus: adjusted food pricing, transportation subsidies, diversified financial aid options, and a "liveable" graduate student stipend**
5. **Increased accessibility of childcare options for students with families**
6. **Investment into women's health (i.e. free menstrual products)**

Mental Health - Although the recent adjustments in mental health services at Cornell Health is the right step forward, it is clear that students' need for care will continue to exceed the current system. I support the need to **increase the wages of current mental health services staff** to more effectively care for students as well as **overall increased staffing**. This process would include **training on effectively supporting diverse students**. One main concern beyond investment is accessibility for mental health services, in which I support **further investment into Cornell Health-based education and support group programs (i.e. Let's Talk)** as well as **alternative, innovative approaches like telehealth** to access students across campus.

Physical Health - It is well-established that physical and mental health are strongly linked and that for many students on campus the ability to exercise helps address school or work-related stresses. However, current fitness and recreation programs are not fully accessible due to various reasons, such as limited hours and parking, overcrowding and costs. I support **improvements to fitness facilities and equipment** as well as **extended fitness hours**, particularly during **evenings, weekends and breaks including summer and winter break**. As well, I advocate for **fitness center membership reimbursement** or alternative methods to cost subsidization.
