## S.A. Resolution #74 1 In Support of an Official Cornell Mascot 2 3 ABSTRACT: In order to foster a sense of community, to enhance school 4 5 spirit, and to celebrate Cornell's rich history and traditions, the Student Assembly calls for the recognition of the Big Red Bear as the official mascot 6 7 of Cornell University. 8 9 Sponsored by: Lisa Liu '15, Syed Ali Khan '15, Sarah Balik '15, and Matthew 10 Henderson'16 11 12 Whereas, traditions lie at the center of the Cornell experience and work to build a sense of 13 community; 14 15 Whereas, in 1915 the Cornell Varsity Football Team used a bear named Touchdown to 16 serve as the original Big Red Bear mascot: 17 18 Whereas, the Big Red Bear has been integrated into Cornell tradition as the unofficial 19 mascot ever since: 20 21 Whereas, Cornell does not have an official mascot but features the Big Red Bear in many 22 Cornell paraphernalia, such as apparel and other merchandise; 23 24 Whereas, the Big Red Bear is also featured on the logo for Cornell Athletics, which play a 25 prominent role in fostering school spirit; 26 27 Whereas, the Big Red Bear is not just connected to athletics but to a larger Cornell history 28 through its presence on university symbols, such as the University Mace and the entrance to 29 Willard Straight Hall: 30 31 Whereas, alumni, friends, and students raised \$25,589 through the site 32 crowdfunding.cornell.edu towards the creation of a bear mascot statue; 33 34 Whereas, the online campaign that rallied the gifts states, "Inspiring Big Red pride, 35 excellence, and camaraderie, Touchdown the Bear is a powerful icon and symbol for the 36 Cornell community"; 37

**Be it therefore resolved,** that the Student Assembly fully supports naming the Big Red

Bear as the official mascot of Cornell University:
