10	Whereas, on October 4 th , 2017, Attorney General Jeff Sessions sent a two-page memo to all
11	United States attorneys and other top officials;
12	Officed States attorneys and other top officials,
12	Whereas, that two-page memo revoked a December 2014 directive from former Attorney
13	General Eric Holder where he ordered the Department of Justice to view "sex" as
15	including gender identity;
16	mendaning gender identity,
17	Whereas, in doing this, the Trump administration has revoked the federal guidelines barring
18	employment discrimination based on gender identity, thus revoking the protections for
19	transgender individuals

21	Whereas, Cornell's official non-discrimination policy includes protection of "sex, sexual
22	orientation, gender identity and expression;"
23	ontennation, genaer raennig and enpression,
23 24	Whereas, gender identity refers to an individual's internal sense of gender, and may be different
25	from or the same as the person's sex assigned at birth;

27	Be it therefore resolved, that Cornell University will continue to uphold their current non-
28	discrimination policy to provide protections to transgender individuals in hiring and
29	employment;

31	Be it further resolved, that Cornell University publicly condemn the Trump Administration's
32	revocation of federal guidelines protecting transgender individuals from employment
33	discrimination;

35	Be it further resolved, that the Student Assembly urges Cornell administration to utilize it's
36	resources in Washington DC to lobby for the reinstatment of the 2014 directive ordering
37	the Department of Justice to view "sex" as including gender identity and the continued
38	protection of LGTQIA+ individuals; and

40	Be it further resolved, that the Student Assembly reaffirms the importance of reporting bias
41	incidents by all members of the community;

43	Be it finally resolved, that Cornell University reaffirms its commitment to supporting people of
