## Resolution 14: In Support of the University Allowing International Graduate Students to TA Remotely During the Summer 2020 Session and the Fall 2020 Semester

5 *Abstract:* Graduate students who are currently abroad and depend on assistantships for financial

6 support do not know whether they will be able to return to the US in time for the start of the

7 Summer 2020 session or the Fall 2020 semester. This resolution encourages the University to find

8 legal ways to provide these students with, in effect, remote teaching positions during the Summer

- 9 2020 session and the Fall 2020 semester.

12 Whereas, many graduate students, encouraged by the University to do so, left campus to return to

13 their home in another country to wait out the COVID-19 pandemic before they knew that their

14 graduate funding would be at risk, and

15 Whereas, many of these graduate students may not be able to return to the United States in time for

16 the fall semester due to travel restrictions or visa and immigration delays, thus potentially preventing

17 them from accepting an in-person teaching assistantship or other in-person assistantship in Summer

- 18 2020 and/or Fall 2020, and
- 19 Whereas, these students are a key part of the Cornell graduate and professional community, and
- 20 represent members of the next generation of innovators in science, the humanities, and other fields, 21 and
- 22 Whereas, continued financial support is key to maintaining these graduate students as part of the
- 23 Cornell community, so that they can return to the University and continue to discover, teach, and
- 24 innovate after the COVID-19 pandemic is over, and
- Whereas, the transition to remote learning at Cornell for the remainder of the 2020 Spring semester has increased the virtual teaching capabilities of both professors and graduate instructors, and
- Whereas, many courses at Cornell have multiple TAs, each of whom have both in-person dutiesand some remote duties (e.g. grading), and
- Whereas, those courses could be reorganized with minimal effort to have TAs who focus solely on remote duties, and
- 31 Whereas, other courses' in-person TA duties, for example lectures, could be conducted virtually on
- 32 Zoom, and

- 33 Whereas, the Graduate School is looking into ways to allow international graduate students to TA
- remotely and the GPSA applauds these efforts, and
- 35 Whereas, students on fellowships are generally not required to be in the country.
- 36 **Be it therefore resolved**, that the University should dedicate significant legal resources to find a
- 37 way to, in effect, allocate virtual TA positions to graduate students living internationally while
- 38 protecting visa status, and
- 39 **Be it further resolved,** if at the end of that research the University concludes that assistantships
- 40 cannot be allocated to students living internationally, the University should coordinate with colleges
- 41 and departments to redirect funds that would have gone to assistantships to expand university
- 42 fellowship programs for affected students
- 43 **Be it finally resolved**, that the University and Graduate School allow all graduate students who are
- 44 stranded abroad and cannot receive their typical TA, RA, GRA, or GA funding to receive a full-
- 45 semester remote TA position (or a legally permissible similar position), or a fellowship position,
- 46 during the Summer 2020 session and Fall 2020 semester.
