# Resolution 38: Recommendation for the Student Activity Fee for 2024-2026

- 3 Abstract: This resolution recommends the respective allocations for the 2024-2026 SAF

#### **Whereas,** lines 324-328 of the Student Assembly Charter state;

"The Student Assembly (the Assembly), through the delegated authority of the President and the Board of Trustees, is charged with the allocation of the Student Activity Fee (SAF). This fee is mandatory for all undergraduate students of the University and shall be used to fund participation in, and viewing of, activities and programs that benefit the Cornell community. The SAF shall be determined during the fall semester of every odd-numbered year, and be subject to the approval of the President of the University."

#### Whereas, lines 511-514 of the Student Assembly Charter state;

"Neither a check-off option nor an option to pay an amount in addition to the established SAF for specific programs or services will be allowed for purposes of exempting a student from paying the full amount of the SAF. Exceptions may be considered if recommended and approved by the Student Assembly and approved by the President of the University."

#### Whereas, lines 545-548 of the Student Assembly Charter state;

"The SA and the GPSA and a representative of the President of the University shall review these guidelines and the procedures established in accordance therewith at least every four years in a non-fee-setting year (e.g. 2014-2015, 2018-2019). This review shall be conducted with strict adherence to the guidelines set forth by the Board of Trustees in Attachment A: Criteria for Setting and Allocating the Student Activity Fee (03/01/99)."

**Be it therefore resolved**, that the Student Assembly recommends the Student Activity Fee be set at \$424, to be distributed as follows (with details on the accompanying Appendix);

# Resolution 42: A Resolution in Support of Amending the Student Suicide Prevention Act

**Abstract:** A resolution to join other student governments in calling the NY State Senate to amend the Student Suicide Prevention Act to include protections for college students.

Whereas, New York State (NYS) has failed to enact any law requiring colleges and universities to develop comprehensive suicide prevention plans for their students.

Whereas, a state-level bill titled the Student Suicide Prevention Act (SSPA), known as Assembly Bill A4788¹ and Senate Bill S1537², has been proposed in the NYS Legislature to mandate the implementation of these resources for students in public 7-12 schools, but fails to address the similar needs of students attending nonpublic schools or NYS colleges and universities.

Whereas, a coalition of collegiate student governments across the state, organized by SUNY Stony Brook student Vignesh Subramanian and the Stony Brook Undergraduate Student Government (USG), is calling for the SSPA to be expanded in scope to include higher education institutions. Over twenty student governments have approved sister resolutions expressing support for this initiative and urging

their respective state lawmakers to take action. Cornell's Student Assembly has been invited to join said coalition.

Whereas, the topic of student suicide prevention is especially relevant to Cornell University, which has been recognized as a particularly high-stress academic environment for many students and as a school with an extended and painful history of student suicides.

**Be it therefore resolved,** that the Cornell Student Assembly stands in solidarity with dozens of student governments across the state in support of the coalition's proposed amendments to the SSPA.

Be it further resolved, that in acknowledgment of the fact that the vast majority of partnering student governments are located downstate, this Assembly urges the student leaders of other universities in Western New York to join us in support of the amendment and passage of the SSPA, in both an effort to promote the legislation and to increase the student body's ties to neighboring universities.

**Be it further resolved,** that this Assembly calls upon NYS lawmakers representing this campus and its students to work collaboratively with their colleagues to expedite the revision and passage of the SSPA, before the current legislative session ends in June 2024.

- Whereas, the Student Assembly has an obligation to allocate funds in the best interest of the
- 12 Cornell University student body.
- Whereas, the Student Activity Funding Commission (SAFC) maintains significant rollover
- 14 funds in its reserve account;
- Whereas, Black Students United is planning a bus trip to the Washington D.C. area on February
- 16 23rd, 2024 to February 26th, 2024 for 38 members;
- Whereas, Black Students United tried to plan this bus trip event last year, but ran into logistical
- issues with Cornell University because of the various Policies or Procedures restricting travel;
- Whereas, Black Students United has planned this trip to adhere to the various travel Policies or
- 20 Procedures and Campus Activities Universal Funding Guidelines<sup>1</sup> in order to ensure this event
- 21 can occur in the Spring 2024 semester;
- Whereas, the Student Activity Funding Commission, as established in Section 2, Appendix A of
- 23 the Charter of the Student Assembly, is the "designated finance commission of the Student
- 24 Assembly";
- 25 **Whereas**, the amount of money being requested by Black Students United is significantly less
- 26 than the total sum of money SAFC has agreed to allow the Student Assembly access to in the
- 27 2023-2024 AY;

- 28 **Be it therefore resolved,** the Student Assembly mandates that the \$\$24,378 transferred from the
- 29 reserve account to be earmarked for usage towards the transportation and lodging for Black
- 30 Students United's trip to Washington, DC.
- 31 **Be it therefore resolved,** Black Students United has an obligation to adhere to all Cornell
- 32 University Policies and Procedures related to travel guidelines, including registering their travel
- 33 with Campus Groups and include a Student Organization Travel Addendum and connecting with
- 34 the Office of Risk Management and Insurance for proper travel waivers;
- 35 **Be it further resolved**, should this planned bus trip be canceled or otherwise not occur, or total
- 36 expenses be less than the expenses elements outlined in their proposed budget, Black Students
- 37 United will be required to give back to the Student Assembly all the unspent allocated monies
- 38 proposed for this trip.
