It is clear that Class Councils takes its work very seriously and we strongly support its general direction and we look forward to working closely with its members in the future.

The Committee recommends that OSC reduce the costs of apparel and volunteer training. Finally, the Committee noted that transfers have very high attendance at OSC's events, and that the cost per head of events could be reduced if OSC focused more of its programming on transfers students.

All of these recommendations notwithstanding, we greatly appreciate the value OSC provides to the student body and we look forward to working closely with them in the near future.
