- i. They're trying to move towards an "Us" mentality instead of "Us vs. Them" mentality
- ii. They're trying to diversify their own experiences with mental health
- iii. Mental health resources will be ongoing process (continuous therapy) instead of one-off process
- iv. Want one place for students to go for resources, specifically a basic needs center for mental health
- v. Want to require a self-care and wellness class in the Cornell curriculum

- vii. M. Song answered that there were student representatives from the Basic Needs Coalition and some admin present who were affiliated with mental health and student services. Will send out exact names and titles in an email
