#### 4. Concurrent Elections for Student-Elected Trustee

Should elections for Student-elected Trustee and Student Assembly be held concurrently:

- Candidates for Student-elected Trustee acting on their behalf may not campaign with or on behalf of candidates for Student Assembly. They are prohibited from engaging in any coordination of campaigning activities outlined in section D.1 with candidates for Student Assembly.
- 2) Candidates for President of the Student Assembly acting on their behalf may not campaign with or on behalf of candidates for Student-elected Trustee. They are prohibited from engaging in any coordination of campaigning activities outlined in section D.1 with candidates for Student-elected Trustee.

5	ABSTRACT: This resolution aims to establish a standing committee of the Student Assembly tasked
6	with the responsibility of providing undergraduate students better representation in the IT
7	governance process at Cornell University.
8

11	Whereas, on February 1st, 2018, the Cornell University Student Assembly established an ad-hoc
12	committee for investigating the campus printing system and advocating for fairer printing pricing
13	schemes, printer accessibility, and environmental sustainability,
14	
15	Whereas, on October 4th, 2018, the SA renewed the aforementioned ad-hoc committee and
16 17	recognized the "Investigative Committee on Stewardship in IT Governance and Campus Printing
17 18	System" as successor to the committee while broadening the scope of the group to address matters regarding Cornell's "stewardship in IT governance practices, and communications between the [SA],
19	and Cornell IT",
20	
	Whereas, the members of the aforementioned ad-hoc committee shall with the presentation of
21 22 23 24	this resolution to the voting members of the SA announce its progress and changes to the campus
23	printing system expected to begin taking effect in July 2019 and hence prepare to conclude its
24	investigation into the Net-Print enterprise,
25 26	
26	Whereas, the new campus printing system will enter the testing phase later this year and a
27	permanent committee of the SA should continue to advocate for student interests during this
28	transition period,
29	
30	Whereas, discussions between the SA and the Cornell computing and information sciences (CIS)
31	community has identified non-printing-related potential areas of improvements for university IT
32	services,
33 34	Whereas, university IT governance remains an area where undergraduates are underrepresented and
35	hence it is of utmost importance that designated members of the SA and the greater campus
36	community maintain the relationships that were built between the SA and the IT administration
37	during the campus printing system reform process,
38	
39	Whereas, the SA does not currently have a committee that deals with matters of IT governance or
40	aims to provide student-side feedback in said area,
41	
42	Be it therefore resolved, the Student Assembly establishes a standing review committee titled the
43	"Student Assembly Committee on IT Governance" through the amendment of the Student
44	Assembly Bylaws to add the following as Article VI, Section 2, Clause P (after line 363):

46	P. Student Assembly Committee on IT Governance - The Student Assembly Committee on IT	
47	Governance (SACIG) is charged with the responsibility of exercising oversight over Cornell	
48	University's information technology services and policies that affect student life. SACIG shall	
49	function to represent student interests in the university IT governance process by conducting	
50	reviews of existing and future policies set by Cornell Information Technologies (CIT), the Office of	
51	the Chief Information Officer (CIO), college and unit IT service groups, and any other relevant	
52	university authorities, as empowered by provisions in Article III, Section 1 of the Student Assembly	
53	Charter. This committee shall be governed by its bylaws, approved following Article VI, Section 1,	
54	Clause A of the Student Assembly Bylaws at the beginning of each Student Assembly term. The	
55	committee bylaws may be amended as necessary when requested by its chair and the amendments	
56		
	have been approved following the aforementioned Clause A. Should this committee fail to approve	
57	its bylaws at the beginning of a Student Assembly Term, its most recently approved bylaws shall take	
58	effect until new amendments are approved. The Student Assembly, when appointing liaisons and	
59	delegations to other shared governance bodies or the administration to represent students regarding	
60	matters of IT governance, should make reasonable efforts to nominate them from the members of	
61	SACIG.

63	SACIG shall consist of no more than 5 voting members, with:	
64	• A chair, an undergraduate student with an interest in computing and technology, elected by	
65	the voting members of the Student Assembly	
66	• Two computing and information science (CIS) representatives – voting members	
67	representing the interests of the CIS community at Cornell – consisted of one appointed by	
68	the Association of Computer Science Undergraduates (ACSU) and another by Women in	
69	Computing at Cornell (WICC), from among students planning to major in, or majoring in	
70	the fields of computer science, information science, or statistical science, and	
71	<ul> <li>Two general representatives – voting members representing the general interests of</li> </ul>	
72	undergraduates – appointed by the chair from among undergraduate students and confirmed	
73	by the Student Assembly Executive Cabinet
