#### IV. New Business

- a. SA R3 Amending the Ratifying the Student Assembly Charter (appendix Amended Chapter)
  - i. This resolution amends and ratifies the Student Assembly Charter. Notable amendments include the creation of the Dyson School of Business

Representative and the creation of an At-large seat reserved for candidates seeking to represent students with disabilities

- ii. L. Smith asked if this process is done once a year
  - 1. N. Watson stated that this is done at the beginning of the year regarding changes from the past term; however, changes can be made throughout the year
- iii. A. Gleiberman inquired about voting regarding ranking candidates; the Charter states "may" be ranked, but the impression she had was that ranking was mandatory
  - 1. N. Watson indicated this was a good catch and that could be changed via a resolution that is presented by an assembly member
- iv. Motion to vote approved 23-0-3
- b. SA R4 Amending and Ratifying the Student Assembly Bylaws (appendix Amended Bylaws)
  - i. This resolution amends and ratifies the Student Assembly Bylaws. Notable amendments include the addition of officer duties for the Vice President of Research and Accountability, a revised system for community voting, and the creation of ex-officio positions for the Student Advocate and the Director of Student Government Relations
  - ii. Motion to vote approved 26-0-1
- c. SA R5 Amending and Ratifying the 2020-2021 Student Assembly Standing Rules
  - i. This resolution amends and ratifies the 2020-2021 Student Assembly Standing Rules
  - ii. Motion to vote approved 26-0-1
