20	Whereas, the former Chair of the Financial Aid Review Committee, Franklin Yang, and SA Vice Preisdnet of Internal Operations, Matthew Henderson, sponsored Academic Year 2014-
21	2015 S.A. Resolution 69, which outlined that "the Financial Aid Review Committee carry out
22	evaluations of the Students Helping Students Fund charter every year to ensure that the fund
23	is up to date and consistent with the needs of the students of the time;"
