17 18 19	Whereas, according to Resolution 57 only the Director(s) of Elections have any power during Summer 2020 in order to effectively run the Fall 2020 election(s);
20 21 22 23	Whereas, unbeknownst to the sponsors of Resolution 57 at the time of writing, many unforeseen circumstances have since arisen that require the Student Assembly to confer and have legislative power in order to advocate for the student body;
