10	Whereas, disabled people are being hurt the most during the current pandemic;
11	
12	Whereas, the marginalization of differently abled people, especially on Cornell's campus,
13	continues to be a regular problem plaguing the student body, and the Students with Disabilities
14	At-Large Representative is the only marginalized-focused representative not expressly given a
15	seat on the committee;
16	
17	Whereas, having a strong desire for intersectionality and promoting marginalized voices are
18	required for a truly diverse representation;
19	
20	Whereas, in the interest of protecting minority voices, a high standard for holding office must be
21	upheld;

23	Be it therefore resolved, the position of Students with Disabilities Representative At-Large will
24	be added to the list of Assembly members required to sit on the Diversity and Inclusion
25	Committee of the Cornell Student Assembly;

27	Be it further resolved, that the Student Assembly Bylaws, Article VI, Section 4, Subsection A,
28	subsubsection d, rule iii (lines 482-485) shall be amended to read:

30	iii. Student Assembly representation: SA LGBT Liaison At-large, Women's
31	representative, International representative, both Minority Liaisons, First Generation
32	Students Representative, Students with Disabilities Representative, and the Vice
33	President of External Affairs are required to be members of the committee.

35	Be it finally resolved, that these amendments to the bylaws will take effect after the new
36 37	Diversity and Inclusion Committee chair is internally elected in Fall 2021.
