Resolution #31 1 2 Audit of Cornell University Administration Finances 3 4 ABSTRACT: This resolution is a formal request for information from the University for Financial 5 Data regarding the University Administration, specifically its resource allocations and general data 6 on wages and salaries of its higher-level staff 7 8 9 Sponsored by: Mitch McBride '17, Diana Li '17 10 11 Whereas, Article III Section 6 of the Student Assembly Charter states, "The SA may request and obtain 12 specific information from the President of the University regarding any subject which it deems 13 of general student concern. If such a request is made, and said information is not furnished, the 14 University President will report to the SA the reasons why said information cannot be furnished 15 within two regularly scheduled SA meeting following the denial of the request. The SA will not 16 request information falling into the following categories: salary or wage records of specific 17 individuals, academic or financial records of specific individuals, medical or categorical (race, sex, 18 age, etc) records of specific individuals and information otherwise defined as confidential or 19 restricted by law;" 20 21 Whereas, Paul Campos, a law professor at the University of Colorado, Boulder and a contributor to the 22 New York Times, brought the attention of the public to the fact that "a major factor driving 23 increasing costs [in tuition] is the constant expansion of university administration" (New York 24 Times); 25 26 Whereas, "According to the Department of Education data, administrative positions at colleges and 27 universities grew by 60 percent between 1993 and 2009, which Bloomberg reported was 10 times 28 the rate of growth of tenured faculty positions" (New York Times); 29 30 Whereas, there is reasonable suspicion that the increased cost of education across the US may well be 31 due to increases in administration sizes and salaries (thus we need Cornell data); 32 33 Whereas, the students of Cornell University deserve the right to know what they pay for as they are the 34 consumers, customers, and contributors; 35 36 Whereas, the Student Assembly expressly does not request any information of specific individuals 37 within the University or information otherwise deemed confidential for privacy or legal 38 concerns; 39 40 Whereas, there are concerns that the administration has grown too large, has given too high of salaries 41 to its higher-level staff, and is too unwilling to disperse with redundant or ineffective employees; 42 43 Whereas, the University must save money from administration expenses in order to dedicate itself to 44 more (not less) generous financial aid policies in order to fulfill its mission of "any person, any 45 study;"
